4a (Code:) (Expenses \$ 428,315. including grants of \$) (Revenue \$) PUBLIC INFORMATION / EDUCATION - THE AIFL WEBINAR SERIES GREW IN TOTAL UNIQUE VIEWERSHIP TO EXCEED 2 MILLION VIEWERS, WITH AN EXPOSURE OF THE ACTIVITIES AND THE ORGANIZATION VIA ONLINE PROMOTION TO NEARLY 12 MILLION VIEWS, AND HAS INCREASED THE VIEWERSHIP FROM SEVERAL HUNDRED PARTICIPANTS AT THE OUTSET, IN EARLY 2020, TO AN AVERAGE EXCEEDING 10,000 UNIQUE VIEWERS PER SESSION ON A CONSISTENT BASIS. THIS IS UNHEARD OF, AS MOST ORGANIZATIONS THAT ENGAGED IN WEBINARS DURING THE COVID YEARS HAVE SEEN THEIR NUMBERS DWINDLE AS LIFE IS RESORTING BACK TO NORMAL, AND HAVE THEREFORE BEEN FORCED TO DISCONTINUE THE WEBINAR ACTIVITY ON A REGULAR BASIS.
