4a (Code:) (Expenses \$ 459,209. including grants of \$) (Revenue \$) PUBLIC INFORMATION / EDUCATION - THE AIFL WEBINAR SERIES GREW IN TOTAL UNIQUE VIEWERSHIP TO EXCEED 2 MILLION VIEWERS, WITH AN EXPOSURE OF THE ACTIVITIES AND THE ORGANIZATION VIA ONLINE PROMOTION TO NEARLY 12 MILLION VIEWS, AND HAS INCREASED THE VIEWERSHIP FROM SEVERAL HUNDRED PARTICIPANTS AT THE OUTSET, IN EARLY 2020, TO AN AVERAGE EXCEEDING 10,000 UNIQUE VIEWERS PER SESSION ON A CONSISTENT BASIS.
